Litter pick notes:

The Council insurance company have confirmed:

"To ensure (insurance) coverage for a litter pick, the Council must conduct a risk assessment, provide appropriate personal protective equipment, conduct a briefing on the day, and establish procedures for handling sharp objects, needles, and syringes."

With regard to any age limits for volunteers, the insurance company have confirmed:

"There is not an age limit on volunteers under the Public Liability. However, if any of the volunteers are under the age of 18, the Council will need to be compliant with the following:

- Your organisation has not had any third-party inspections with a grading of Inadequate, Requires Urgent Improvement, Weak or Unsatisfactory.
- You have in place a written safeguarding policy and accompanying procedures that clearly set out the actions to take in response to child and vulnerable adult abuse.
- You carry out safer recruitment and selection processes that include the seeking of appropriate criminal records checks, alongside a renewal and update process.
- All employees and volunteers engaged in regulated activity and/or activity that brings them into contact with children or vulnerable adults receive safeguarding awareness training including refresher training.
- You have one or more designated practitioners for safeguarding to support other practitioners in the organisation to recognise and respond to concerns about abuse.
- You retain employment records, safeguarding checks, safeguarding policies and procedures and safeguarding records for at least the prevailing regulatory best practice period."
