Clerk Report/Update March 2024

- A member of the public reported fly tipping in the parish to B Cllr Lintern, this
 included corrugated asbestos on the verge opposite the beet pad along Green Drove,
 off Murgot's Lane, and at the footpath entrance to Green Drove fly tipped fence
 panels, guttering and a tree stump. B Cllr Lintern and myself have both reported
 these to the Borough Council. Reply from Borough:
 - The asbestos will be collected by our contractor in due course.
 - In regards to the other waste reported we have been unable to locate the fence panels, guttering or tree stump. There is what looks like to be some construction waste on the beet pad, however due to this being private land we are unable to clear.
